Recent DDPC COUNCIL News

The Council is seeking members from **outside the Albuquerque metro area**. All applications need to go through the Governor's website: <http://www.governor.state.nm.us/>. On the website there is a drop-down box "Governor's Office" where you can chose "Boards and Commissions" and click on the line for "Apply for a Board Position." In the application, you can apply for the Council.

Guardianship Program Update: If you would like to request a **presentation on guardianship**, contact Maria Bourassa, Guardianship Program Manager at 505-841-4524 or maria.bourassa@state.nm.us. The Guardianship Program has been hard at work with court hearings, site visits to Guardianship providers and preparing the new online database.

Federal Program Update: This program provides funding from the United States Department of Health and Human Services, Administration for Community Living/Administration on Intellectual and Developmental Disabilities (AIDD) to engage in advocacy, capacity building and system change activities for individuals with developmental disabilities. This initiative conducts and supports programs, projects and activities that carry out the purpose of the Developmental Disabilities Assistance and Bill of Rights Act of 2000.

For example, the Federal Program funds **Disability Rights Awareness Day on February 23 and 24**. DDPC funds two contractors for DRAD: The Arc of New Mexico, who coordinates the DRAD logistics and Disability Rights New Mexico, who coordinates the DRAD Program through the Disability Coalition Steering Committee. DRAD is an annual disability convention in Santa Fe that coincides with the NM legislative session. Advocates are trained and empowered by advocating directly with legislators about their needs.

Center for Self Advocacy (CSA) Update: The Center staff will be attending and supporting the **Know Your Rights Town Hall Meetings** for Advocates, Family Members and Guardians in February, March, and early April. [Learn more](#). The February Town Halls will be held in Albuquerque, Santa Fe, Las Cruces, and Taos.

The CSA staff is also preparing to present a 14-week pilot of their new Advocate Coach Training (ACT) leadership development program for individuals with intellectual/developmental disabilities that begins in March. He did many tasks and had a great learning experience during his two year term. He then was hired on as a Project Assistant in 2012 at the Center who continued his work on outreach and antibullying campaigns until taking his current

position last August.

He graduated with Honors with an MA Special Education from the University of New Mexico and won the 2013 Outstanding Student with a Disability Award from the Southwest Conference on Disability. He also received the 2011 Bob Thomas Award for Disability Advocacy from The Arc of New Mexico and will receive the Liz Thomson Award from Partners in Policymaking. He has collaborated and volunteered with many organizations including the Jemez Vocational Rehabilitation Advisory Council, the New Mexico Autism Society, People First of New Mexico, New Mexico Young Disability Leaders, and New Mexico Allies for Advocacy among others.
