

**Federal Program Update:** The Federal Program projects directly relate to the current Five-Year Plan (2017-2021) developed and approved by the Council. The Five-Year Plan is based on input received from people with disabilities, family members, professionals and community members from across the state.

Funding for these projects are from the United States Department of Health and Human Services, Administration for Community Living/Administration on Intellectual and Developmental Disabilities (AIDD).

For example, the Arc of New Mexico is funded to put on the **Statewide Self-Advocacy Summit** on Friday, June 16, at the Hyatt Regency Albuquerque. The theme of this year's conference is "Know Your Rights, So You Can Live The Life You Want." This conference covers human rights, advocacy, and more for people with disabilities statewide. It also awards distinct individuals who make a difference in the disability community.

#### Center for Self Advocacy (CSA) Update:

As directed by the Five-Year Plan, DDPC/CSA staff are conducting a 14-week pilot of the new *Advocate Leadership Academy*, a leadership development program for individuals with intellectual/developmental disabilities. The pilot program began in March and ends in June. The Academy Fellows are participating in designing events like the upcoming **Summit on Advocacy** and the **Summer Fun Series**.

#### Know Your Rights Steering Committee Meeting

A coalition of different groups and individuals is working on the Know Your Rights campaign which addresses the Final Rule and rights of individuals with disabilities. The Final Rule amends the regulations which govern the Medicaid 1915 (c) Home and Community Based Services (HCBS) waiver programs. These rules are an important step forward in federal policy, supporting inclusion and integration of people with intellectual and developmental disabilities in the community.
