**Federal Program Update:** The Federal Program projects directly relate to the current Five-Year Plan (2017-2021) developed and approved by the Council. The Five-Year Plan is based on input received from people with disabilities, family members, professionals and community members from across the state.

Funding for these projects is from the United States Department of Health and Human Services, Administration for Community Living/Administration on Intellectual and Developmental Disabilities (AIDD).

For example, the Federal Program funds the **Information Network** at the UNM Center for Development & Disability. The Network is a comprehensive information service to the New Mexico disability community through referrals to various agencies and by staff traveling across the state providing informational materials.

The Federal Program completed a **survey** to identify **health services gaps** which was sent to DDPC federal program contractors to share with their project participants and send back to DDPC with their quarterly reports.

### Center for Self Advocacy (CSA) Update:



The Center for Self Advocacy held the first three classes of the *Advocate Leadership Academy* in August with:

- 7 Team Leaders (Self-advocates mentoring new advocates)
- 7 fellows (new advocates people with disabilities & family members)
- 1 advocate from outside of the Albuquerque area.
- Classes are focused on disability awareness, the importance of balancing life priorities and an introduction to the program itself.

- Academy participants complete weekly journal entries
- Focus on goals and action steps related to self-awareness.

Program Manager Daniel Ekman presented about Know Your Rights and Guardianship at the *New Mexico Guardianship Association Symposium* on August 25. DDPC intern Matt Castillo also began to work with the CSA Program during the last week of August. Also, a panel of CSA participants spoke to a class of Occupational Therapy students about their experience in the *Academy*, as well as, their own personal life lessons. CSA staff have also helped mentor the current *LEND* self-advocacy fellow as part of their collaboration on the *AUCD Diversity Grant* project with the *University of New Mexico Center for Development and Disability*.

### **Medicaid Telephone Identity Theft Scam Alert**

# The Following comes from the New Mexico Human Services Department Website

There have been reports of what appears to be an identity theft scam by callers claiming to be representatives of the New Mexico Medicaid program. These solicitors are calling individuals several times a day and asking for their name, Social Security Number, and Medicaid number. Medicaid recipients should never provide personal information such as Social Security Number or Medicaid identification numbers over the phone to unsolicited callers.

These callers are not affiliated with the New Mexico Human Services Department, its Medicaid program, the Centennial Care managed care organizations, or the Centers for Medicare and Medicaid Services.

If you have received an unsolicited call from someone claiming to be a representative of the Human Services Department or the New Mexico Medicaid program, you may file a complaint with the Federal Trade Commission at https://www.ftccomplaintassistant.gov. If you have already fallen victim to this or a similar scam, please visit http://www.identitytheft.gov.

### **Know Your Rights**

A coalition of different groups and individuals is working on the **Know Your Rights** campaign which addresses the CMS Final Rule and rights of individuals with disabilities. The Final Rule amends the regulations which govern the Medicaid 1915 (c) Home and Community Based Services (HCBS) waiver programs. These rules are an important step forward in federal policy, supporting inclusion and integration of people with intellectual and developmental disabilities in the community.

## From Fear to Freedom Grant Project





New Mexico Allies for Advocacy is partnering with Parents Reaching Out on a \$15,000 grant project. "From Fear to Freedom: Family Support Groups and Know Your Rights" is a collaborative effort between Parents Reaching Out (PRO) and New Mexico Allies for Advocacy (Allies) to educate the parents of children with disabilities about their rights in adulthood. Through this effort, we hope to address misconceptions about the Know Your Rights campaign, help parents understand why the Know Your Rights campaign is important for their children, raise the expectations that parents have for their future adult children with disabilities and increase the dialogue about future opportunities between parents and their children with disabilities.

"From Fear to Freedom" reflects a synergy among the goals of these three programs. One objective is to raise awareness of rights for parents with disabilities by offering education and communication opportunities in 10 communities. Another objective is to get relevant information from the Know Your Rights campaign to the parents, in particular through adults with disabilities sharing how misconceptions about adults with disabilities impact them. Adult self-advocates will also share their success stories from their adult lives. In doing so, this will create a new normative expectation of rights for parents not just in the present, but when their children become adults. Finally, the project will create a link between adult self-advocates and their initiatives, parents and their initiatives, and communities to create a shared vision of what the future will look like for children with disabilities.
