## **New Rules Strengthen Civil Rights for People with Developmental Disabilities**

**Albuquerque, NM:** New rules from the Federal Centers for Medicare and Medicaid Services strengthen the rights of people receiving waiver services. These new rules will be explained to people on the Developmental Disabilities (DD), Mi Via, or Medically Fragile Waivers, Family Members, Advocates, and Guardians at nine “Know Your Rights” Town Hall Meetings.

“This campaign and the rule changes that come with it are about the ideas that the focus should be the person who gets the services and making it possible, practical, and real in the everyday lives of those people,” said Daniel Ekman, Program Manager, Center for Self Advocacy at the Developmental Disabilities Planning Council.

The new rules will help people on waivers:

- Be part of the community where they live and work,
- Choose where they live, who they live with, and how they live,
- Decide how to spend their days and who to spend their days with, and
- Determine who provides services.
